

University of California, San Diego Consent to Act as a Research Subject

Cognitive Science Courses: 102A Distributed Cognition, 102B Cognitive Ethnography, 102C Cognitive Engineering, 120 Human-Computer Interaction, 198 and 199 Independent Study

is conducting a research study to find out more about the nature of everyday cognitive activity and/or interactions with technological systems. You have been asked to participate in this study because you are engaged in an everyday cognitive activity or interaction with technology. Students in these courses work with hundreds of participants like you every quarter.

The purpose of this study is two-fold. First, it gives the student named above an opportunity to practice the skills of cognitive ethnography and contextual design. Second, it contributes to the scientific understanding of the nature of cognitive activity in real-world settings.

If you agree to be in this study, the following will happen to you:

The researcher will make an audio recording of your ongoing everyday activities. The recording will last between 30 minutes and one hour. The student researchers will then transcribe and analyze the recording. As part of the grading process in the students course, the recording transcript and analysis may be read by instructors in the course, or by other students in the course.

Participation in this study may involve some risks or discomforts. These include the following:

- 1. A potential for the loss of confidentiality. Your name will not appear in the transcript of the interview nor will it appear in the analysis. If the transcript and analysis are read by other students in the class, neither your name nor the name of the student researcher will be available to the readers. Research records may be reviewed by the UCSD Institutional Review Board.
- 2. The student researcher has been instructed to NOT interview you about subjects that make you uncomfortable. If the interview becomes uncomfortable you may terminate the interview at any time at no risk. Simply tell the researcher that you do not wish to continue.

Because this is a research study, there may also be some unknown risks that are currently unforeseeable. You will be informed of any significant new findings.

The alternative to participation in this study is to choose not to participate.

There will not be any direct benefit to you from participating this study and you will receive no compensation for participating. The investigator, however, may learn more about the nature of everyday cognition, and society may benefit from this knowledge.

Participation in research is entirely voluntary. You may refuse to participate or withdraw or refuse to answer specific questions in an interview at any time without penalty. There will be no cost to you for participating in this study.

The student researcher named above has explained this study to you and answered your questions. If you have other questions or research-related problems, you may contact the course instructor. For Cogs102A
